Since 2018, faculty members in Political Science have published (or have forthcoming) a total of 10 books, 3 edited volumes, 138 articles in refereed academic journals, and 28 chapters in edited volumes. This does not include book reviews, popular press articles, blog posts, encyclopedia entries, technical reports, and other public facing articles. The faculty also present their findings regularly at academic conferences around the country (usually about 40-45 papers a year).
